Claiming a single priority	Evidence that the priority date of filing the patent in Vietnam is 8 <sup>th</sup> April 2021, which is the date of filing the patent in Sri Lanka.
Request for formality and substantive examination including search	Receipt of request.
Publication of application	Receipt of publication.

The duration of the service is for 01 months from the date of signing the contract.
