

# UNIVERSITY OF MORATUWA REGISTRATION OF SUPPLIERS FOR THE YEAR- 2020

Applications are invited from reputed Suppliers, Manufacturers, and Local Agents & Sole Distributors who wish to register themselves with the University of Moratuwa for the supply of Goods during the year 2020. The applicant should pay a non-refundable fee of Rs. 2,000/- for EACH CATEGORY OF ITEMS for which registration is applied, to the bank account of University of Moratuwa, Account No.306836 maintained at Bank of Ceylon-Katubedda branch. The original of deposit slip should be forwarded along with the application to the University. Application should be prepared according to the specimen available and sent under registered cover with "Registration of Suppliers, Year - 2020" marked on the top left-hand corner of the envelope to reach the Deputy Bursar/Supplies, University of Moratuwa, Katubedda, Moratuwa on or before 13<sup>th</sup> November 2019. The specimen application can be downloaded from the University Website, www.mrt.ac.lk or can be obtained from the Supplies Division, University of Moratuwa either in person or by post up to 2.00p.m. On 13<sup>th</sup> November 2019.

The University of Moratuwa will generally call for quotations from the registered suppliers of the relevant categories. However, it reserves the right with the university to call quotations from those who are not registered as well. Suppliers who fail to quote when requested or fail to make delivery in time in conformity with the given requirements will be struck off their registration in the Register without prior intimation.

#### **Conditions of Registration**

# • Suppliers eligible for Registration

- 1. The applicant (relevant business organization) should posses a valid Business Registration.
- 2. The applicant must be the manufacturer / owner of the registered trade mark of the product or an authorized re-seller, agent of the manufacturer / if you intend to supply goods under Sub Category I.
- 3. The applicant should have at least 03 years of experience in supplying the relevant product(s). Submit relevant documents along with the Application.
- 4. The applicant should agree and have the capacity to provide a credit period minimum of 30 days in the event he/she is being selected for supply of goods.

#### Documents to be submitted with the application for registration

- 1. Duly completed application form based on the specimen provided, (a copy of the application form can be downloaded from the university website www.mrt.ac.lk or obtained free of charge directly from the Supplies Division, Administration Building, University of Moratuwa.)
- 2. A receipt of payment as per the instructions given and with the total amount based on the number of categories to which the registration is applied.
- 3. Certified copy of the Business Registration.
- 4. If the applicant is a limited liability company, a copy of the Certificate of Incorporation.
- A certified copy of the VAT registration or VAT-exemption certificate issued by the Commissioner General of Inland Revenue.
- 6. If you are charging VAT on invoices, forwarded a letter obtained from Dept.of Inland Revenue mentioning you have a VAT Active file.
- 7. A letter of authorization from the manufacturer / trade mark owner if the applicant is an agent or re-seller of the products.
- 8. Copies of purchase orders / invoices relating to largest supplies of items of similar category made to government / private sector organizations during the years 2017, 2018, & 2019.
- 9. Above Item No.7 & 8 will not apply for those who wish to supply goods under sub category II.

#### • Other terms and conditions

- 1. Applicants who have registered with the University for the year 2019 or earlier MUST apply for the registration for year 2020, if they wish to have their registration for the year 2020.
- 2. Applicant should mark "Registration of Suppliers, Year -2020" on the top left -hand corner of the envelope.
- 3. Non submission of request documents, along with the application, will not be considered for Registration for Year 2020.
- 4. Any Supplier who has not responded twice for an invitation to submit a Quotation or performed unsatisfactory under any procurement previously awarded, will be removed from the Supplier Registration.
